## Barron County 4-H Shooting Sports Member and Family Expectations

We are dedicated to teaching firearm/archery safety and responsibility and share opportunities to explore the outdoors/wildlife ecology to all, while allowing kids to experience the fun and excitement of shooting sports and the outdoors.

The goal of the 4-H Shooting Sports project is to promote youth development by instilling safe habits, self-discipline, teamwork, youth leadership, and knowledge in a safe, family-oriented, and encouraging environment. Shooting disciplines that are taught to 4-H members (ages 8 as of January 1 of the 4-H year {and 3rd grade} to one year following high school graduation) include: archery, air rifle/rifle, air pistol/pistol, shotgun, muzzleloading, wildlife, and forestry. Supervision of this program is under the direction of the UW - Madison Division of Extension. All participants are responsible for their conduct to UW-Madison Div. of Extension personnel and to the 4-H volunteer leaders supervising this program.

In addition to the expectations set forth by Wisconsin/Barron County 4-H and their policies, the following behaviors are requested of all members and their families. These behaviors contribute to a successful learning environment. As our family enrolls in the shooting sports project(s) (archery, air rifle/rifle, air pistol/pistol, shotgun, muzzleloading, wildlife and forestry), we agree to the following expectations.

We will:

- Have read and reviewed the safety rules, range and etiquette rules and am responsible to know and understand and follow the rules.
- I assume responsibility for loss or damage of my own equipment/supplies while participating in the programs.
- Use good judgment in selecting clothing appropriate to the occasion and weather.
- Use language and manners that will bring respect to ourselves and to Barron Co. 4-H.
- Be in the assigned areas at all times. Aggressive play or similar actions inside/outside of the buildings is prohibited.
- Show courtesy and respect for all other people. Demonstrate good sportsmanship.
- Do not take photos or videos of other youth/adults without their permission.
- No action cameras (no body cams) to be used on the range or at meetings; exception: if being used with permission for educational/instructional use by certified leader. Videotaping of shooting technique by certified leader for instructional use may be done with permission.
- Help other members have a pleasant experience by making every attempt to include all participants in activities.
- Live up to your highest expectations so you can be proud of who you are and what you have done.
- Abide by the Barron Co. 4-H Youth Behavior Agreement which you signed when you enrolled in 4-H.

As a member/parent, I understand that I need to follow the above expectations. If the expectations are not followed, I understand the adult leaders will talk with me about what behavior needs to be changed. If the behavior continues the leader will provide a written warning to my parent/guardian. If the behavior continues after the written warning, the situation will be referred to Barron Co 4-H Program Educator for review. If the situation warrants, the member may be removed from the shooting sports project (s).

I will allow photos/videos to be taken of my child to be used by Barron County 4-H Shooting Sports for exhibits, published in local newspapers, and Extension publications, or published the Barron County 4-H Website or in other digital media. (we ask permission before names are shared)
